Minutes of the Meeting of the Parish Council held at the Grosvenor Park School on Thursday 17th March 2022 at 7:00 pm.

- **2365** Apologies: Apologies were received from Councillor Mr P Melling and Councillors Mrs G Kelly and Mr K Percy both due to ill health.
- **Minutes**: It was **RESOLVED** that the minutes of the meeting held on Thursday 24th February 2022 be approved.
- **2367** Declarations of interest: There were no declarations of interest.

2368 Public discussion and information only updates:

1. **Public discussion**: There were no members of the general public present at the meeting. No issues/comments were raised by members of the public to the Parish Clerk in advance of the meeting for discussion.

2. Parish Clerk report and correspondence

The Parish Clerk presented his report setting out updates on previous actions, activities, resolutions, and correspondence received as follows;

Lancaster City Council (LCC) have now confirmed that the cuttings/waste left in the storm drainage ditch at Dunsop Gardens within the Grosvenor Park estate have now been removed. The issues with the Duck House building and its general state of disrepair is being looked into by LCC who are trying to establish ownership and responsibility.

A formal application for funds to refurbish the Portland Drive play area is currently being completed. The application for funds is being made to the Lancashire Environmental Fund (LEF). The draft application has been forwarded to Lancaster City Council for their assistance and provision of supplementary information required by LEF. A video of the play area showing its current condition is required which will be made by Councillors Wright and Melling shortly.

The request for the two additional litter bins, to be funded by the Parish Council and sent to Lancaster City Council for their action has been chased up.

The Parish Council Insurance renewal is due on the 01.04.2022. Details of additional items owned by the Parish Council (three litter bins and two Tommies) have been forwarded to the insurers for their information and assessment.

Detail of estate roads where the Parish Lengthsman will carry out weed killer treatment is still required. Councillors were asked to provide a list of prioritised estate roads in their Ward, which were within the Parish, where weed growth on the footway was an issue.

3. Parish Council (Councillors) updates and information only reports:

The Chair asked for Councillors with updates or information to report:

Councillor Wright advised that he had completed the first draft of the formal application to the Lancashire Environmental Fund (LEF) for the funding for the Portland Drive play area. The draft application had been passed to the Parish Clerk for review and completion of outstanding information. Councillor Wright advised that he

would contact Councillor Melling and arrange for the video of the area to be made. The deadline for submission of the application is 07.04.2022 at 17:00hrs.

Councillor Wright advised that he had noticed 'Road Closed Here' signs on Oxcliffe Road for later in the month. The Parish Clerk advised that he had received no notification from the Lancashire County Council Streetworks Team and advised he would look into this.

Councillor Simmons advised that he had noticed a lot of litter and general waste items in and around the lagoon area in the Grosvenor Park estate. The Parish Clerk advised that a Street Scene report could be made to Lancaster City Council reporting the issues.

Once again, the Parish Council meeting was held face-to-face. It was agreed by all Councillors present that Parish Council meetings would continue to be held face-to-face for the immediate future and that this item would now be removed from the meeting agenda.
