## **PARISH OF HEATON-WITH-OXCLIFFE** Minutes of the Meeting of the Parish Council held at the Grosvenor Park School on Thursday 19<sup>th</sup> May 2022 at 7:00 pm.

- Apologies: Apologies were received from Councillor Mr K Percy due to ill health and 2383 County Councillor Charlie Edwards.
- 2384 Minutes: It was **RESOLVED** that the minutes of the meeting held on Thursday 21<sup>st</sup> April 2022 be approved.

#### 2385 **Declarations of interest:** There were no declarations of interest.

### Public discussion and information only updates: 2386

**Public discussion**: There were no members of the general public present at the 1. meeting. No issues/comments were raised by members of the public to the Parish Clerk in advance of the meeting for discussion.

### 2. Parish Clerk report and correspondence

The Parish Clerk presented his report setting out updates on previous actions, activities, resolutions, and correspondence received as follows;

There had been no update received relating to the formal application for funds to refurbish the Portland Drive play area following submission to the Lancashire Environmental Fund (LEF).

The request for the two additional litter bins, funded by the Parish Council, sent to Lancaster City Council (LCC) has now been formally agreed. There had been a small increase to the purchase cost of the bins and a date for their installation is to be provided shortly once the bins have been ordered and received by LCC.

The Parish Clerk advised Councillors that the current IT support contactor was becoming increasingly unreliable. The Parish Clerk proposed that an alternative IT support should be sourced. Councillors agreed with this suggestion.

Current details relating to the access/egress of the new housing development adjacent to Oxcliffe Road had been forwarded to Councillors for their information.

A request had been received from Parish resident regarding their concerns over construction works being carried out to a property within the Parish. The Parish Clerk advised that in conjunction with Lancaster City Council (LCC) Planning Department he had provided the resident with current planning application details and a link to LCC webpage where a complaint could be formally submitted.

There had been no update received from Lancaster City Council relating to establishing the ownership of the Grosvenor Park estate lagoon area Duck House. The Duck House is in need of repair, but ownership needs to be established before any maintenance work could be considered.

Debris from in and around the Grosvenor Park estate lagoon area had not all been removed. Further pictures provided by Councillor Melling had been passed to Lancaster City Council for their information and action.

Parish Council (Councillors) updates and information only reports: The Chair asked for Councillors with updates or information to report: Councillor Melling advised that he and his wife had carried out a clean up in and around the Lagoon area and around the Grosvenor Park estate sign. It was agreed by Councillors that the loose bricks around the sign base could be repaired by the Parish Lengthsman. Councillor Melling commented that the Lagoon area perimeter fencing was in need of repainting. It was agreed by Councillors that a request would be made by the Parish Clerk to Lancaster City Council for this maintenance work to be carried out. Councillor Wright commented on the recent issue at the Portland Drive play area. Broken glass on the footpath and adjacent grassed area running through the park had been reported to him by a resident. Following discussion with the Parish Clerk the issue was reported to Lancaster City Council. Councillors were advised that where there is an issue that does not readily fit with the 'Report It' facility direct contact via email to the Public Realm Team could be made. The Parish Clerk advised that he would provide the contact details to Councillors following the meeting.
