Minutes of the Meeting of the Parish Council held at the Grosvenor Park School on Tuesday 21st February 2023 at 7:00 pm.

The Chair welcomed all attendees to the meeting.

- **2433 Apologies:** Apologies were received from Councillor Mr K Percy due to ill health and Councillor Simmons.
- **2434 Minutes**: It was **RESOLVED** that the minutes of the meeting held on Thursday 12th January 2023 be approved.
- **2435 Declarations of interest:** There were no declarations of interest.

2436 Public discussion and information only updates:

1. Public discussion:

A resident who lives in the Parish was in attendance at the meeting. The following concerns and issues were raised to the Parish Council.

Littering on the Grosvenor Park estate was getting worse. The resident felt that the primary cause of the littering was by young adults attending the nearby Lancaster and Morecambe College.

A discussion was held by Councillors and with the resident. Councillors advised that the Parish Council were aware of the littering issue for some time and had contacted the College on a number of occasions to formally complain.

Complaints to the College can be made by members of the general public via the College website. In the past the Parish Council had used this facility to make complaints and raise concerns and had always received a response to their correspondence. In addition to this the Parish Council had installed two additional litter bins in the Grosvenor Park area. The Parish Clerk advised that he had this week noticed litter picking on Morecambe Road adjacent to the College being carried out by the College. The Chair advised that any member of the general public can complain directly to the College if they feel the littering issue is being caused by College pupils. The Chair also advised that littering is a public offence and if witnessed by members of the public this can be reported directly to the Police using the 101-contact number.

The resident also advised that they were planning to try and arrange, with other residents, for a localised litter pick to be carried out. Councillor Melling advised that the Parish Council had historically arranged and carried out a number of litter picking initiatives within the Parish, and this would be a good idea.

Lancaster City Council had recently carried out clearing and dredging works to the dyke on the Grosvenor Park estate. The resident felt that this work, only recently carried out, was detrimental to the wildlife and had reduced the flow of water in the dyke area.

A discussion was held by Councillors and with the resident. Councillors advised that this was the first time the dyke had been cleared in many, many years. The Parish Clerk advised that he had contacted Lancaster City Council to ask them if an ecological assessment had been carried out and what considerations with regards wildlife had been taken prior to carrying out the clearing works. Once a response is received this will be communicated via Parish Council meeting minutes and displayed in the three Parish Council notice boards located in the Parish.

The Chair thanked the resident for their attendance and for raising their concerns to the Parish Council. The resident thanked Councillors for their time and left the meeting.

2. Parish Clerk report and correspondence

A request has been made to Lancaster City Council Environmental Services for some 'no dog fouling' signs following complaints from a number of residents to the Parish Clerk. Once received the Parish Lengthsman would be able to fix the signs to localised areas/locations where reports of dog fouling have been received. The Parish Clerk advised that dog fouling is a public offence and if witnessed it can be reported to the police on the 101-contact number or directly to the Lancaster City Council Environments Services Department.

The Parish Council Insurance renewal for 2023/24 has been received. There has been a 10% increase to the premium. The Parish Clerk advised he was currently discussing the renewal details with the current insurance provider.

The Lancaster City Council (LCC) 'report it' web-based reporting facility has recently been refreshed and updated. Details had been sent to Councillors for their information. The 'report it' facility can be found on the LCC website.

3. Parish Council (Councillors) updates and information only reports:

The Chair asked for Councillors with updates or information to report.

Councillor Baxter advised that she was currently in discussion with Lancashire County Council Highways Department with regards to the replacement of the give-way junction carriageway lining which had been removed following the resurfacing work carried out on Heaton Bottom Road. The junction give-way white lining has not yet been replaced.

Councillor Wright advised that Mellishaw Lane footway had now been tidied up and the overhanging brambles and vegetation removed/cut back from overhanging the footway.

Councillor Melling advised that the repair to a dangerous manhole on the Bay Gateway (near-to the Honda garage) has been repaired but the repair had failed, and he would now need to re report the dangerous manhole again.
