Minutes of the Meeting of the Parish Council held at the Grosvenor Park School on Thursday 16th March 2023 at 7:00 pm.

The Chair welcomed all attendees to the meeting.

- **2441 Apologies:** Apologies were received from Councillors Mrs M Baxter, Mr J Simmons and Mr K Percy all due to ill health.
- **2442 Minutes**: It was **RESOLVED** that the minutes of the meeting held on Tuesday 21st February 2023 be approved.
- **2443 Declarations of interest:** There were no declarations of interest.

2444 Public discussion and information only updates:

1. Public discussion:

There were no members of the general public present at the meeting. No issues/comments were raised by members of the public to the Parish Clerk in advance of the meeting for discussion.

2. Parish Clerk report and correspondence

Lancaster City Council Environmental Services have provided the Parish Council with a number 'no dog fouling' signs. The signs have been passed to the Parish Lengthsman who will erect the signs onto street light posts and general sign posts at agreed locations around the Parish. The Parish Clerk asked Councillors to propose some locations in the Parish where dog fouling is an issue. The Lengthsman could then erect the signs in these specific areas as well as at the Grosvenor Park play area where Resident complaints had been received.

A request has been made by a City Councillor for a grit bin to be provided and funded by the Parish Council and erected on the Grosvenor Park estate close to the Grosvenor Park School. Details relating to the request had been passed to Councillors in advance of the meeting for their consideration. Lancashire County Council had also been approached to supply the new grit bin prior to the request being made to the Parish Council, but the new supply did not meet their specific assessment criteria for a new grit bin at this location. A discussion was held by Councillors, and it was agreed that the Parish Council did not feel that it was appropriate to supply a new grit bin in the area.

The Parish Clerk had contacted Lancaster City Council regarding the recent dyke clearing carried out within the Parish following environmental and flooding concerns raised by Residents. A response had not yet been received.

The carriageway pothole identified by Councillor Baxter to the Parish Clerk was reported to Lancashire County Council (LCC) by the Parish Clerk using the LCC 'report it' app. The pothole has now been repaired. The issue regarding the flooding on Lancaster Road at Mill Hill House is still a problem and yet to be resolved. The Parish Clerk advised he would try and take some photos of the

flooding to support the report to ensure LCC are aware of the exact location.

A quotation for the supply and set up of a computer and printer for the Parish Council has been received from Bowker IT. The Parish Council does not currently own a computer or printer that can be specifically used by the Parish Clerk for Parish Council business. A discussion was held by Councillors, and it was agreed that the Parish Clerk would arrange for payment of the quotation to made and the invoice would be presented at the next meeting.

Lancaster City Council have advised that they are hoping to start the refurbishment of the Portland Drive play area week commending 03.04.2023. The refurbishment works are being funded by the Parish Council and through a grant received from the Lancashire Environmental Fund.

3. Parish Council (Councillors) updates and information only reports:

The Chair asked for Councillors with updates or information to report.

There were no reports from Councillors at this time. A discussion was held by Councillors regarding their recent attendance at the Lancaster City Council candidate briefing session held at Lancaster Town Hall.
