#### **PARISH OF HEATON-WITH-OXCLIFFE**

Minutes of the Meeting of the Parish Council held at the Grosvenor Park School on Thursday 28<sup>th</sup> March 2024 at 7:00 pm.

#### In Attendance:

The Chair welcomed all attendees to the meeting.

- **2526** Apologies: There were no apologies, all Councillors were present.
- **2527 Minutes**: It was **RESOLVED** that the minutes of the meeting held on 22<sup>nd</sup> February 2024 be approved.
- **2528** Declarations of interest: There were no declarations of interest.

### 2529 Public discussion and information only updates:

#### 1. Public discussion:

There was one member of the general public (David Morgan) present. David Morgan, who lives in the Parish, had recently applied to be co-opted onto the Parish Council. David had been invited to attend the Parish Council meeting to enable Councillors to consider his request to be co-opted onto the Parish Council as Councillor for the vacant Winster Park Ward.

The Chair adjourned the meeting and introduced David Morgan and asked David to provide a brief summary of why he felt he would be suitable to join the Parish Council. David gave a brief summary of his past experiences, in a professional working environment, and his current leisure and free time interests. David also identified a number of areas where he felt he could bring added benefit to the Parish Council such as website management and contacts with Lancaster City Council. Councillors then asked David a number of questions to enable them to assess his suitability for the role of Parish Councillor.

No other issues or comments were raised by members of the public to the Parish Clerk in advance of the meeting for discussion, so the Chair then thanked David for his attendance and interest in joining the Parish Council and re-convened the meeting. David remained in the meeting to enable him to gain experience of a Parish Council meeting.

### 2. Parish Clerk report and correspondence

The draft contract for the annual grant fund for the Fanny House Farm Energy Storage Project has now been agreed. Innova have advised the Parish Council that their legal team will be sending out the formal contract for signing, by the Chair and Parish Clerk, in due course.

The presentation planned for this evening by the architect working with David Cox, of Cox Motors who own the VW Motor dealership on Mellishaw Lane, has been cancelled. The reason for the cancellation was due to further changes that

need to be made to the design. Once these changes have been made and the formal application re-submitted to Lancaster City Council a new date for the presentation will be agreed.

The application for a free framed Kings portrait has been submitted. Once received the portrait will be gifted to the Grosvenor Park School.

A new date for the Annual Meeting of the Parish Council has been agreed. The Annual Meeting will now be held on the 23.05.2024, along with the usual monthly meeting, providing the annual accounts summary has been completed and an internal audit carried out.

The issue regarding debris and rubbish left on site left following the ditching and cleaning out of the dyke at Green Lane and Sunderland Drive has been forwarded to Lancashire County Council (LCC) for their attention. Lancaster City Council confirmed that the dykes in this area are private and not their responsibility and any complaints should be passed to LCC.

The missing litter bin, that had been provided by the Parish Council, on the cycle/pedestrian way adjacent to ASDA has now been replaced by Lancaster City Council. Details of the locations of the five litter bins provided by the Parish Council have been passed to Lancaster City Council with a request for the bins to not be moved to other locations.

The refreshing of the carriageway yellow 'School Keep Clear' lining adjacent to the Grosvenor Park School has been carried out by Lancashire County Council.

#### 3. Parish Council (Councillors) updates and information only reports:

Councillor Melling advised that he had now met on site with Lancaster City Council (LCC) representatives following his report of pollution concerns and trees and bushes being thrown into the dyke which flows within the Grosvenor Park housing estate.

LCC have advised that they will arrange for the removal of the cut trees and bushes. They also advised that pollution concerns should be reported to the Environment Agency (EA) via their Incident Hotline on 0800 807060. Councillor Melling advised that the pollution concerns have now been reported to the EA.

The Parish Clerk advised that there had been two new planning applications received since the last meeting. Details had been sent to Councillors in advance of the meeting for their comment. Planning application **24/00262/FUL** was unanimously supported by the Parish Council. Planning application **23/00553/FUL** was majority not supported by the Parish Council. The reason for the Parish Council not supporting the application was they felt that the drainage provision for the site had not been adequately addressed. The Parish Clerk advised that he had updated the Lancaster City Council Planning Applications and Decisions portal in line with

the Parish Council decisions.

#### **2531 Planning application decisions:**

Councillors reviewed the Planning Application Comments and Decisions for February/March 2024 which had been updated and sent to Councillors for their information in advance of the meeting. The Parish Clerk advised planning application **23/00381/RCN** had been permitted on the 13.03.2024. There had been no updates to any of the other ongoing planning applications.

The Parish Clerk advised that he would begin the process for co-option following the meeting.
