Minutes of the Meeting of the Parish Council held at the Grosvenor Park School on Thursday 13th
June 2024 at 7:00 pm.

The Chair welcomed all attendees to the meeting.

- **2553 Apologies:** Apologies were received from Councillor Simmons and Councillor Kelly due to ill health.
- **Minutes**: It was **RESOLVED** that the minutes of the meeting held on 23rd May 2024 be approved.
- **2555 Declarations of interest:** There were no declarations of interest.

2556 Public discussion and information only updates:

1. Public discussion:

There were no members of the general public present at the meeting. No issues/comments were raised by members of the public to the Parish Clerk in advance of the meeting for discussion.

2. Parish Clerk report and correspondence:

Lancaster City Council have been advised that the missing litter bin, that had been provided by the Parish Council on the cycle/pedestrian way adjacent to AXA Insurance, is still missing.

A request for the Parish Council to join the Public Rights of Way and Biodiversity grant scheme for 2024/25 has been made to Lancashire County Council.

The electronic contract has been signed and returned for the Fanny House Farm Community Benefit Scheme.

The hedgehog gates have been ordered from Hedgehogs R US.

Lancaster City Council Planning Department have been in contact with the resident on the Grosvenor Park housing estate where there had been a number of complaints received relating to the sight line issues at the junction Lune Drive and Hodder Avenue. The sight line issues were caused by the location and height of the fence.

The minutes of the Lancashire Association of Local Councils (LALC) meeting held on the 23.05.2024 have been received and passed on to Councillors for their information. The date of the next meeting is planned for the 17.07.2024.

The Annual Governance and Accountability Return 2023/24 Form 2 Certificate of Exemption AGAR Form 2 has been forwarded to the Government appointed external auditors pfk Littlejohn Limited for their information. Details of the Certificate of Exemption, Section 1 - Annual Governance Statement 2023/24 and Section 2 - Accounting Statements 2023/24 have been placed on the

Parish Council notice boards and website. In addition to the above the Notice of Public Rights and Publication of Annual Governance and Accountability Return (Exempt Authority) has also been placed on the Parish Council notice boards and website. The document provides details and advice relating to the requirement of the Parish Council to make their accounting records and AGAR available for inspection by any person interested, for a specified period of time.

3. Parish Council (Councillors) updates and information only reports:

Councillor Melling advised that Councillor Kelly had been contacted by a Resident who lives on the Grosvenor Park estate regarding a fence problem and overgrown brambles at the rear of Wenning Court. Councillor Melling suggested that in the first instance the Parish Lengthsman could have a look to see if he could resolve the issue. This suggestion was agreed by the other Councillors present.

Councillor Melling advised that there was also a possible issue with a small shed and leaning fence that is making access to a footpath at Wenning Court on the Grosvenor Park estate very difficult to access. Councillor Melling advised he would provide some photos showing where the issue was. Once received the Parish Clerk would inform Lancaster City Council Development Control Team of the issue.

The Chair advised that he had seen a planning application fixed to street furniture on Green Lane proposing that part of the Green Lane Public Right of Way (PRoW) was being changed to a bridleway. The Parish Clerk said that he would contact Lancaster City Council Planning Department to confirm if this was the case. The Parish Clerk thought that the Parish Council should have been made aware of this proposal for their comment.
