Minutes of the Meeting of the Parish Council held at the Grosvenor Park School on Thursday 16<sup>th</sup> January 2025 at 7:00 pm.

The Chair welcomed all attendees to the meeting.

- **2585 Apologies:** Apologies were received from Councillors Mr P Melling and Mr D Morgan.
- **Minutes**: It was **RESOLVED** that the minutes of the meeting held on 12<sup>th</sup> December 2024 be approved.
- **2587 Declarations of interest:** There were no declarations of interest.

### **2588** Public discussion and information only updates:

#### 1. Public discussion:

There were no members of the general public present at the meeting. No issues/comments were raised by members of the public to the Parish Clerk in advance of the meeting for discussion.

### 2. Parish Clerk report and correspondence:

The concrete block blocking access to the Mellishaw Lane Public Right of Way (PRoW) reported to Lancashire County Council (LCC) PRoW Team has been acknowledged. At this time the LCC PRoW Team are considering what action, if any, to take. The LCC PRoW Team feel that the position of the concrete block allows access to the general public on foot but is preventing unauthorised access by bikes and quad bikes. The Parish Council have however pointed out to the LCC PRoW Team that access is not possible for members of the general public using a wheelchair and/or with a pram.

The provisional dates for the 2025 Parish Council meetings have been confirmed by the Grosvenor Park School Bursar and forwarded to Councillors for their information.

Confirmation has been received from Lancaster City Council that they have now adopted the Grosvenor Park play area and as such all future maintenance and repairs will be their responsibility.

A Precept application of £13,169.80 for the Parish Council running costs for the period 01.04.2025 to 31.03.2026 has been made to Lancaster City Council.

The street lighting and footway issues between Salisbury Close and Coltsfoot Walk have been considered by Lancaster City Council Engineering Department.

They have advised that the street lighting and highway in this area are Lancashire County Council (LCC) responsibility. Councillor Wright advised that he would report the footway issues to LCC via the Love Clean Streets reporting App.

The Parish Clerk reminded Councillors that he will be on holiday leave from the 25<sup>th</sup> January to 9<sup>th</sup> February.

The Parish Clerk has agreed with a local accounting company, who are willing to carry out the monthly payroll for the Parish Council, that they will manage the Parish Council payroll. The management of the Parish Council payroll will start on the 01.04.2025. The accounting company will also manage any employee national insurance employer implications given the changes identified in the recent central government budget.

### 3. Parish Council (Councillors) updates and information only reports:

Councillor Wright advised that he has now visited the Portland Drive play area to review the repair work carried out by Lancaster City Council. The repairs to the broken fence and repairs to the play area equipment and floor have been carried out.

Councillor Wright advised that he attended the Lancashire Association of Local Councils (LALC) meeting held at Morecambe Town Hall on the 15.01.2025. The minutes of the meeting will be passed to Councillors once they have been received. The meeting was attended by the Local Police who discussed a number of topics relating to theft and the issues being caused by scooters and high-powered e-bikes in the area.
