Minutes of the Meeting of the Parish Council held at the Grosvenor Park School on Thursday 27th February 2025 at 7:00 pm.

The Chair welcomed all attendees to the meeting.

- **2593 Apologies:** Apologies were received from Councillor Mr D Morgan and Mr J Simmons.
- **2594 Minutes**: It was **RESOLVED** that the minutes of the meeting held on 16th January 2025 be approved.
- **2595 Declarations of interest:** There were no declarations of interest.

2596 Public discussion and information only updates:

1. Public discussion:

There were no members of the general public present at the meeting. No issues/comments were raised by members of the public to the Parish Clerk in advance of the meeting for discussion.

2. Parish Clerk report and correspondence:

A request has been made from a member of the general public, Liz Howard-Thornton who is a volunteer with the Commonwealth War Graves Commission (CWGC). The request relates to John Crowther who was a victim (Fireman) killed in the White Lund Munitions Factory explosion 1st October 1917. The request was for Parish Council funds to be used to restore the headstone of John Crowther who is laid to rest at the Providence United Methodist Chapelyard, Burnley Road, Burnley. John Crowther is buried in a private family grave and his grave does not come under the remit of the CWGC and as such their funds are not available for the restoration of the headstone. A discussion was held by Councillors, Whilst Councillors are aware of the sacrifice made by John Crowther over 100 years ago Councillors did not feel there was sufficient surplus funds available within the Parish Council finances at this time.

A request has been made for the minutes of the last Lancashire Association of Local Councils (LALC) area meeting held on the 15.01.2025.

The Parish Clerk reminded Councillors that he will be on holiday leave from the 08.03.2025 to the 17.03.2025.

A request was made by the Parish Clerk to change the July meeting from the 17.07.2025 to the 24.07.2025. A discussion was held by Councillors, and it was

agreed the date change was acceptable. The Parish Clerk advised he would inform all Councillors of the change via email.

3. Parish Council (Councillors) updates and information only reports:

Councillor Melling advised that he had agreed with the Grosvenor Park School Head Teacher a location for his oak tree to be planted at the rear of the school. The oak tree will be planted to commemorate the life of the late Keith Percy. Keith was an active member of the Parish Council for over 30 years. Councillor Melling also suggested that a plaque, identifying the service provided to the Heaton With Oxcliffe Parish Council by Keith Percy, would be erected at the site of the oak tree. Peter asked Councillors to forward their suggestions for the wording to be used on the plaque. Peter advised that he was looking at the 14.04.2025 for the plaque to be sited adjacent to the oak tree. He hoped that Councillors and the wife of the late Keith Percy would attend the site for the erecting of the plaque.

Councillor Wright advised that he would report the slippery and worn footway issues at Salisbury Close and Coltsfoot Walk to LCC via the Love Clean Streets reporting app.
