Minutes of the Meeting of the Parish Council held at the Grosvenor Park School on Thursday 16th October 2025 at 7:00 pm.

The Chair welcomed all attendees to the meeting.

- **2649** Apologies: There were no apologies.
- **2650 Minutes**: It was **RESOLVED** that the minutes of the meeting held on 21st August 2025 be approved.
- **2651 Declarations of interest:** There were no declarations of interest.

2652 Public discussion and information only updates:

1. Public discussion:

There were no members of the general public present at the meeting. No issues/comments were raised by members of the public to the Parish Clerk in advance of the meeting for discussion.

2. Parish Clerk report and correspondence:

The Parish Council vacancies for the Rural and Winster Wards remain open. Any member of the general public who may be interested in becoming a Parish Councillor should contact the Parish Clerk on 07916029265 for further details.

The Parish Clerk advised he would be attending a Teams Meeting arranged by Lancaster City Council to present and explain their new waste strategy. Details would be fed back in due course. Details explaining the three phases of the new waste strategy had been received from Kellet Ward Councillor James Sommerville and forwarded to the Councillors last week.

The two Tommies had been collected by the Lengthsman and would be erected at the Stocks, adjacent to the A683 Bay Gateway shortly.

Monthly maintenance checks to the three Public Right of Ways (PROW) in the Parish will end in November and restart in March 2026. Only reported reactive maintenance will be carried out to PROW during this period.

The Lengthsman had reported to the Parish Clerk an instance of fly tipping on Lancaster Road near to the Golden Ball Hotel. The materials tipped contained personal address details. These details have been forwarded to the Lancaster City Council Environmental Management Team for their action.

The new Lancashire County Council (LCC) Enquiries System for entering and tracking an enquiry has been forwarded to Councillors for their information and future use. The Enquiries System covers a wide range of services that are provided by LCC. The Love Clean Streets App remains the primary way to report Highway related defects.

A Prior Notice Application to upgrade a bridleway footpath on Green Lane, had been forwarded to Councillors for their information and comment. The majority of Councillors were not in favour of the change from footpath to bridleway. Full details of reasons for their objection will be forwarded to the Lancashire County Council Legal Services Department in due course.

Parish Council (Councillors) updates and information only reports:

Councillor Simmons advised he had attended the recent 'Coffee With A Cop' Initiative that was held at Starbucks adjacent to the ASDA Supermarket. A wide range of subjects were discussed including the Lancaster/Morecambe Cycle/Pedestrian Way (Way). At the meeting a local Police Constable advised that checks had recently been carried out on the electric cycles and scooters using the Way. A number of illegal electric cycles had been confiscated. The next 'Coffee With a Cop' is planned for 24.10.2025 at 10.00am at ASDA Café.

Councillor Simmons noted his continued concern with the groups of young adults, most likely from the Lancaster and Morecambe College (L&MC), who are congregating in and around the Grosvenor Park play area. When approached and advised they are too old to use the play area the young adults become abusive. Details of these instances have been passed to the L&MC Principal for his attention and action. Details have also been passed to the local area Police Officer for his assistance.

Councillor Wright advised that he had attended the recant Lancashire Association of Local Councils (LALC) Lancaster Area meeting on the 06.10.2025. Relevant subjects and issues discussed were the Lancaster and Morecambe cycle/pedestrian way (Way) and the ongoing Local Government Reorganisation/Devolution Proposals that will have an impact on the Lancaster and Morecambe area.

A recent police initiative of checking e-bikes and scooters on the (Way) had resulted in the confiscation of 24 scooters and e-bikes.

The Chair advised that he had met a member of the Lancaster City Council (LCC) grounds maintenance team to look at carrying out some much-needed maintenance within the fenced off area of the Grosvenor Park Estate lagoon area. Following this visit a decision will be made by LCC as to whether the Residents working party will be allowed to carry out the maintenance. If not, the maintenance work would be carried out by LCC maintenance team directly.

The Chair asked if the Parish Clerk (PC) could look into providing information relating to signing up for and receiving information for enabling a Neighbourhood Watch scheme for the Grosvenor Park estate. The (PC) advised he would look into this.
